INTERNATIONAL STUDENT REFUND AGREEMENT

- All course fees and charges are payable in Australian Dollars (AUD\$) in accordance with the Current Fee Schedule
- All fees and charges must be paid in advance by the date shown on the Offer of course placement and/or invoice.
- Enrolment Fee and Accommodation Booking Fees not refundable.
- Fees will be refunded:

(a) In the event of a default by the provider, the student shall be entitled to a Full Refund under the provision of the ESOS Act 2000 and ESOS Regulations 2001. These refunds will be made within 14 days. Or,

(b) In the event of a default by the student, then

- If a student withdraws from a course and supplies SCCVE written notification of more than 28 days before the course commencement date, 80% of the total course fees paid will be refunded.
- If a student withdraws from a course less than 28 days before the course commencement date, 60% of the total course fees paid will be refunded.
- The student is not granted a student visa. In this instance, application must be accompanied by a rejection letter from the Australian Embassy, that documentary evidence must be supplied within fourteen (14) days of visa rejection.
- Health Cover Premium is refunded in full before arrival in Australia. Not refundable after arrival.
- tuition fees are not refundable or transferable after the commencement date except for compassionate grounds
- Applications for refund must be made in writing and must be received by SCCVE no later than 3 months after commencement of the course. Application received after 3 months will not be processed.
- This Agreement will not remove the right for the student to take further action under Australian Consumer Protection Laws. SCCVE's dispute resolution processes do not inhibit the student the right to pursue other legal remedies.

- Refunds will be made in Australian Dollars (AUD\$) within 4 weeks of receiving a written request, and are not transferable to any other party. Refunds may be payable to the party that made the initial course payment.

SCCVE reserves the right to modify any timetables, course schedules, Institute fees and refund policy to reflect changing circumstances.
